- 1) A deposit is required at the signing of this Agreement.
- 2) The balance is due no later than the scheduled date of the rehearsal. Payments made on the day of the rehearsal **MUST BE MADE PRIOR TO THE START TIME OF THE EVENT**. Neither Praise Unlimited Ministries, Inc. nor any of its agents will perform until full payment is received.
- 3) Payment is required on the scheduled date of the rehearsal regardless of cancellations due to inclement weather, location or change of heart by either bride or groom.
- 4) Praise Unlimited Ministries, Inc., its artists, staff, affiliates or agents are responsible for malfunctions in any equipment not provided by us. This includes keyboards, organs, PA systems, alarms, plugs, wires or outlets. This Agreement hereby releases and holds harmless Praise Unlimited Ministries, Inc. from any legal actions and/or lawsuits resulting from same.
- 5) Praise Unlimited Ministries, Inc.'s performers and/or artists are entitled to reasonable breaks during the engagement. They are not employees of the client and shall perform without client supervision. Additionally, it is asked that they be entitled to consume non-alcoholic beverages and light fare (i.e. bottled water, soft drinks, fresh fruits etc.)
- 6) A reasonable area be provided for Praise Unlimited Ministries, Inc. to sell/promote tapes, CDs, videos and to display business materials for future engagements.
- 7) **The initial deposit will be refunded within seven (7) business days of signing this agreement ONLY.** Requests for refunds made after this time will be **DENIED**.
- 8) **A \$50.00 returned check fee will be assessed for all returned checks.**
